

General terms and conditions

govern the basic rights and conditions of cooperation between the customer (s) of the purchased event ticket (hereinafter "participant", "you") on the one hand and J.C.Trade Bridge International s.r.o. (hereinafter referred to as "Administrator", "we," "us" or "our") ID: 35787848, with its registered office at Hrobákova 26, 85102 Bratislava, on the other hand.

I. Definition of terms, introductory provisions

1.2. The owner and operator of the website <https://www.autonomousvehiclessummit.eu> ("Site") is the Administrator with its registered office at Hrobákova 26, 85102 Bratislava.

1.3. General basic agreement to terms as concerns site

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and administrator, concerning your access to and use of the <https://www.autonomousvehiclessummit.eu> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively,

1.4. Intellectual property rights

2. Event

The Autonomous Vehicles Summit (hereinafter referred to as the “Summit”) is an international hybrid format conference of a nature held in the territory of the Slovak Republic, for which tickets are sold through the e-shop, and organized by the Autonomous Vehicles Summit: the largest autonomous vehicle event in Central and Eastern Europe, Bratislava, 09.-10.12 , 2021 . Due to the development of the situation and uncertainty in the context of Corona COVID-19, the event will be realized in an in person/online virtual formate (futher in text “hybrid formate conference”, “event, “ Summit”) . The two-day hybrid formate conference "Autonomous Vehicles Summit" is focused on mobility, including autonomous vehicles and the conditions of their adoption in the cities and regions of the country, innovations in the automotive industry, user applications of other sectors of the Slovak economy and with the presentation of some of their innovative autonomous vehicles. vehicles, and follows the trends of the current digital transformation in context. The summit will include lectures and panels of the hybrid formate conference with round tables, including the scientific and technological part of the conference with online moderated panel discussions of the summit topics.

3. Event organizer

The administrator is the organizer of the AutonomousVehiclesSummit hybrid formate conference event and ensures the sale of tickets for this event through its own sales e-shop on the website <https://www.autonomousvehiclessummit.eu/>. Contacts and bank details of the administrator can be found on the website <https://www.autonomousvehiclessummit.eu/> in the Contact section

4. E-shop

An e-shop is a computer system located on the Internet with public access that allows you to order goods.

5. Seller

The seller is Administrator, Hrobákova 26, 85102 Bratislava.

6. Supplier

The supplier of the service offered in the e-shop on the Site is the Administrator with its registered office at Hrobákova 26, 85102 Bratislava

7. Buyer

The buyer is any visitor to the e-shop who has created an order through the e-shop (hereinafter referred to as the "Participant").

8. The order

The order is created by confirming the ordering process in the e-shop by the buyer, including the complete completion of the registration form and payment of the participation price.

1.8.1. Registration of the participant

You agree that by accessing the Site, you have read, understood, and agree to be bound by all of these Terms of Use

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated in by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms of Use at any time and for any reason.

The Site is intended for users who are at least 18 years old. Persons under the age of 18 are not permitted to use or register for the Site.

You agree to keep your password used by registration confidential and will be responsible for all use of your account and password. We reserve the right to remove, reclaim, or change a username you select if we determine, in our sole discretion, that such username is inappropriate, obscene, or otherwise objectionable.

9. Confirmation: Confirmation means the e-mail sent to the buyer to the e-mail address specified in the order. Such e-mail includes information on the payment of the entrance fee for the event participation , and for online attendees also the information with a web link to participate in the event online.

10. Ticket

A ticket to the Summit is created by complete registration of the buyer in the e-shop and payment of the entrance fee according to the offer of the Administrator for online participation in the Summit. Its confirmation from the Administrator allows for a one-time fee online participation in the Summit during both days of the Summit (hereinafter referred to as the "Ticket")

11. Entrance to summit

With regard to governmental measures for protection against COVID-19, in case of in person summit participation , entry to the summit is allowed only for participants fully vaccinated against COVID-19 . Each participant must present a vaccination EUR passport, digital QR code or official relevant confirmation (document) upon entry at the summit reception.

II.The price

All prices listed on the Site are final. This also applies to time-defined prices. Early bird Administrator is not a VAT payer.

The administrator is bound by the price relations listed on the e-shop website at the time of making the purchase.

III.Order, payment and ticket

1. How to order a ticket for in person or online participation in the Summit

1.1. By sending the completed order form Registration on the Site website and payment of the relevant amount published in the e-shop on the Site is a ticket. Participant can made a choice to participate on summit in person or online in the Summit.

1.2. After filling in the registration form, the applicant is redirected to the GPWebPay payment gateway, where he / she will pay for the ticket with a payment card. After the payment has been made, a success letter full email will be sent to the contact email specified in the order, confirming the payment made by the buyer of the order with the right to participate in the Summit in person or online.

2. Maximum number of participants on summit , who can make registrations to buy tickets and can attend summit

2.1. Number of in person participants to summit is limit max 100 persons. Reaching 100 registrations system shall be stopped possibility to buy tickets .

2.2. Number of on-line participants to summit is not limited

IV.Terms of payment

You can pay for the Summit ticket via the GP WebPay payment gateway with one of the following payment cards: Mastercard, Visa, Dinnersclub or American Express, or transfer via the payment button of selected banks.

V. Scope of services, change of scope of services, cancellation

1. Scope of services:

1.1. After receiving the confirmation - e-mail with information for all participants who paid for tickets ,about the payment of the entrance fee to the event. For online participants system will generate also the information with a web link to participate online in the event, the participant has the right to participate actively onthe Summit via the web link, for the entire duration, 09.-10.12.2021 and watch and join the whole course of the event online

1.2. Each summit participant has the opportunity to define his questions on the topics of lectures on the chat system within the panel discussions Summit online

1.3. Each summit participant has the opportunity to use B2matching system of the event

2. Change in the scope of services

The offer of services and their use may be limited or changed due to force majeure, e.g. . due to the health condition of the lecturers, etc. The organizer reserves the right to change the agenda / program of the event. In the event that there are serious reasons related to the restriction of the offered event in advance, the organizer is obliged to inform the ticket holders via e-mail or on the website about the change, cancellation, replacement date of the event.

3. Summit Cancellation

Upon cancellation of the event, the Participant will be fully refunded in full.

Upon cancellation of the event, the funds representing the ticket price are returned to the bank account of the ticket holder from which the ticket price was paid, unless the ticket holder notifies the event organizer of another account to be credited within 3 working days after the scheduled event. funds representing the price paid for the ticket.

In the case of purchasing a Ticket, it is not possible to withdraw from the contract with the organizer and request a refund of the entrance fee when the ticket was purchased via the website of the e-shop on the Site after 12.8.2020.

VI. Privacy

Administrator, as the organizer of the summit, in connection with the sale of tickets in accordance with the relevant provisions of Act no. 118/2018 Z.z. (Slovakia) on the protection of personal data obtains and processes personal data of ticket holders, especially in the scope of name, surname, address, telephone / e-mail contact, or title, date of birth, for the purpose of providing a specific service, managing the contractual relations of ticket holders and event organizers. The information provided to the organizer via the order form will no longer be provided to third parties. The organizer will use them only for his own needs in accordance with Act no. 18/2018 Coll. on the protection of personal data to improve and manage its services, for business and marketing purposes of

the company. All data having the nature of personal data, in accordance with Act no. 18/2018 Coll., Are obtained exclusively on the basis of the consent of the persons concerned, while the persons concerned declare that they provide the operator with unconditional consent to the processing of such personal data, provided that this consent can be revoked at any time and the consent is given for a predetermined purpose and , with the processing of which the person concerned agrees. The Operator guarantees that the processed personal data protects against their disclosure to third parties and that it stores and uses them exclusively for the specified purpose and in accordance with Act no. 18/2018 Coll.

Registered participant in accordance with Act no. 18/2018 Coll. agrees that J.C.Trade Bridge International s.r.o. with its registered office at Hrobáková 26, 85102 Bratislava, organizer - administrator of the summit, processed, stored and used the personal data provided to the participants, to the extent necessary for the specified purpose and to the extent provided by the participant, in accordance with legal security principles and legal protection of this personal data.

VII. Alternative dispute resolution

If the participant (buyer of tickets for the hybrid summit) is not satisfied with the way in which the administrator implemented the summit under this General terms and conditions , he has the opportunity to contact the administrator with a request for redress. If the administrator responds to the request for redress in a negative manner or does not respond to it within 30 days from the date of its sending, the participant has, in accordance with § 12 of Act no. 391/2015 Coll. on Alternative Resolution of Consumer Disputes and on Amendments to Certain Acts The right to file a motion to initiate an alternative resolution of one's dispute. The relevant subject for alternative resolution of consumer disputes with the e-shop operator is the Slovak Trade Inspection (www.soi.sk) or another relevant authorized legal entity registered in the list of alternative dispute resolution entities maintained by the Ministry of Economy of the Slovak Republic (<http://www.mhsr.en/list-of-subjects-of-alternative-resolution-of-consumer-disputes/146987s>), while the participant (buyer) has the right to choose to contact any of the mentioned subjects of alternative-dispute resolution of consumer disputes. At the same time, the participant may use the online dispute resolution platform available at <http://ec.europa.eu/consumers/odr/> to submit a proposal for an alternative dispute resolution. Information on application fees can be found by the consumer on the website of a specific ADR entity.

VIII. Final provisions

The condition for accepting the order and purchasing a ticket for the event is the expression of consent to these general terms and conditions, which contain both the rights and obligations of the participant and organizer and also consent to the provision and processing of personal data of the participant as a person concerned by the organizer.

Consent to these general terms and conditions, the participant will express by marking this consent on the registration form administrator on the site. The indication of consent in this form is considered, in accordance with the relevant legal regulations, as a written expression of the participant's will with these general terms and conditions, as the application form is generated using data about a specific participant who expresses his individual consent in this form. Consent to these general terms and conditions is also consent to the use of personal data provided under the GDPR, as the provision of data and consent to their processing is an integral part of these general terms and conditions. By purchasing a ticket and indicating consent to these general terms and conditions on the website, the ticket holder agrees to the general terms and conditions of the administrator. The participant confirms that he has read these general terms and conditions, understood them, his possibility of active participation and modification of their content has been preserved and agrees with them in full. The seller reserves the right to change these general terms and conditions. The obligation to notify the change of these general terms and conditions in writing is fulfilled by placing them on the seller's e-commerce website and each time you purchase a ticket and express your consent to these general terms and conditions, the content of these terms and conditions is guaranteed.

In the event that certain rights and obligations are not regulated in these general terms and conditions, the provisions of applicable legislation of the Slovak Republic shall apply, in particular and not exclusively the Civil Code, the Commercial Code, consumer protection legislation and Act no. 18/2018 Coll. on the protection of personal data.

These general terms and conditions take effect against the buyer participant by ordering a ticket and simultaneously expressing the participant's consent to these general terms and conditions and Terms of personal data protection. These general terms and conditions govern the rights and obligations of the parties, the organizer of the event and the participant of the event, as well as contain the basic principles of personal data protection in their acquisition, storage and processing by the organizer.
